The latter includes measures such as setting up the Early Learning Centres in the Women Prisons in Karachi and Hyderabad. In these centres, the CWP strives to the rehabilitative standards of the women prisoners, or any child born to or accompanying any of them.

MESSAGE FROM the Deputy Inspector General Women & YOIS Prisons and Corrections Services

n the early days of the formation of the Committee for the Welfare of Prisoners (CWP). Justice Nasir Aslam Zahid would visit the Women Prison daily and hold meetings with prisoners who were unable to engage a lawyer. He interviewed each prisoner individually to assess her financial standing and the merits of her case. I recall that his arrival at the prison was seen as a source of insurmountable hope encouragement for and the women prisoners who

From the children being taught basic literacy for reintegration into society upon release, to improving the menstrual hygiene standards among the prisoners, there are quite a number of ambitious initiatives that have radically improved the provision of welfare for prisoners. In addition, the Prison Paralegal Program has created a sustainable system of legal empowerment of prisoners who no longer have to rely on external support to understand the nuances of

desperately sought legal aid. His wife, who is a retired doctor, would accompany him to screen and treat patients for scabies and other infectious diseases.

Such empathy and commitment towards protecting the rights of the vulnerable have become enshrined in the fabric of CWP since its inception, and it is because of these qualities that have enabled the committee to have such tremendous impact till date.

INAUGURATION CEREMONY OF PARALEGAL ROOM in Central Prison Hyderabad

paralegal room was inaugurated at the Central Prison, Hyderabad on June 25, 2021, by Mr. Muzaffar Alam Siddiqui (DIG Prisons Hyderabad). The prison now has a fully functional prison paralegal service that provides legal awareness to new prison admissions in a sustainable and supervised manner. It is a rare example of direct legal empowerment within prisons under which literate convicts are trained to be able to provide legal awareness and information to other prisons in order to acquaint them with prison rules and with the nuances of the justice sector.

During the inauguration, Superintendent, Mr. Zia ul Hassan distributed appreciation certificates among the paralegals. The Sindh Prisons leadership in Hyderabad emphasized the role of Paralegals to sustain the concept of legal empowerment among the under-trial prisoners and also appreciated the efforts of CWP-LAO and thanked the organization for its support.

WP-LAO believes that legal awareness sensitization and towards rule of law should be an integral part of the training curriculum for all law enforcement professionals. A greater need was realized to improve capacities and to reflect on the major changes in New Sindh Prisons Rules.

In this regard, the Committee of the Welfare of Prisoners-Legal Aid Office organized a one-day training session for Sindh Prison Officials on the 'Sindh Prisons and Corrections Services Rules, 2020' on June



ORIENTATION SESSION ON CASE MANAGEMENT SYSTEM for all CWP-LAO Advocates

WP-LAO launched its very own web-based Management •Case System (CMS) in March of 2015. CMS is an automatic system that reduces the day-to-day operations of an advocate to create, maintain update their and cases as well as their hearings manually. It is completely operated by the advocates within the organization and helps them manage their cases more efficiently and more productively. One of the key components of CMS is its user-friendly online platform, which our advocates are able to access anywhere with the help of an internet connection using a smart phone or laptop among other electronics.

Since it was launched, CMS is being utilized by CWP-LAO advocates, which covers 24 prisons of Sindh province where free legal aid is provided to Under Trial Prisoners. In May 2021, CWP-LAO CMS phase II was rolled out. This phase covers the new system features along with upgraded reporting mechanisms that will help advocates perform То operationalize the updated system, online zoom training sessions have been conducted in which all advocates including those in regional offices have been trained to use it with the features for better management and execution.







ACKNOWLEDGMENT OF CWP-LAO SERVICES across 18 Prisons in Sindh

In order to create greater awareness of the vast work being done by CWP-LAO and to ensure transparency and accountability, a visibility board was designed to display CWP-LAO's Annual progress and free legal aid clinics schedule within prisons.

The CWP-LAO installed visibility boards across 18 Prisons of Sindh, the majority of which are installed in the entrance/main area of the prisons. These will allow prisoners to be aware of the services being provided by CWP-LAO for their benefit.

FREE LEGAL AID and Advisory Camps

WP-LAO plays a critical role in disseminating information on rights, access to justice services, and access to benefits on COVID-19 response. During the second & third waves of the Covid-19 pandemic, these camps were conducted with the safety guidelines/SOPs since the CWP- LAO team

took the necessary measures in prisons to effectively control risks of a possible spread.

The objective of these camps is to provide basic legal aid to prisoners in conflict with the law at multiple stages of their interaction with the justice system. From entry into the justice system at the police station through the prosecution department, through the trial process in court, all the way to prison if a person is remanded or is serving a sentence, the

legal aid provided is helpful at multiple stages of this process.

The advisory camps are also used to spread awareness about the rights and responsibilities of users of the justice system. Multi-format IEC materials were distributed among prisoners to inform them about the newly notified Prison rules 2020 and the availability of mechanisms for access to justice





JUSTICE SUCCESS STORIES

Mohammad Ashraf, gets acquitted from false attempt-to-murder charges

ohammad Ashraf is a 36 years old laborer, is the sole provider of three sons and one daughter (all minors) as well as his ailing parents, and was implicated in multiple offenses such as carrying an illegal weapon, and charges owing to a fabricated case of a murderous attack on the police. As his socioand economic political background is working-class and he is someone who must provide for those dependent on him, Ashraf struggles to make ends meet.

He requested CWP-LAO to represent him in court for his defense. LAO **Advocate Mohammad Toseef** speedily took up the case and filed it

on March 22, 2021. He took extra time to ensure that the challan submitted was done so properly and did well to coordinate with the prosecution on this matter.

the evidence Once and statements had been recorded and played out, the proceedings concluded having exonerated Ashraf of all charges, as the court determined that there were many contradictions in the prosecutions' witness statement. Ashraf was thus acquitted from all charges on April 1, 2021, by extending the benefit of the doubt. He is very thankful to CWP for their support and aid that reunited him with his family and allowed



him another opportunity to provide for them. Had he not been able to get LAO on board with his case, he would have faced imprisonment for a term that may extend to 14 years plus a fine.





Muhammad Mithal Samito, gets justice after being involved in a false Narcotics case

uhammad Mithal Samito was a 45 year old resident of Dadu, and a family man with ten to twelve dependents on him when he was arrested for possession of hashish (or charas) as part of a routine police patrol. Belonging to a working-class background, Mithal found himself in a very alarming situation on account of being behind bars, and not being able to provide for his family.

He finally got in touch with LAO Advocate **Mr. Naveed Khan Ujjan** who came to visit him in jail and went on to represent him. His case was filed on the 12th of January 2021, and the

proceedings began. Mithal plead not guilty, and the case went ahead with witness statements and arguments.

The court concluded that the prosecution was not able to prove their charges against Mithal, who was acquitted on the 9th of April 2021. If he did not have LAO representing him, he could have faced a sentence of up to 7 years with a fine. Upon being released, he thanked his advocate, CWP-LAO, and the efforts of Justice Nasir Aslam Zahid with the Sindh Government in improving the state of prisoner's rights in Pakistan.







Joein Ilyas, gets reunited with his family after being falsely accused in a robbery case

oein Ilyas was 18 years when he was accused of trespassing within and theft of items taken from a school in Gulistan-e-Johar, Karachi, He hails from a working-class background, is the sole provider in his family, and also belongs to a minority community. Given the financial and social background of the accused, he was vulnerable to issues emerging in povertystricken circumstances, and required free legal representation.

Ilyas approached LAO advocate **Mr. Abid Jatoi** to represent him, who filed the case on April 6, 2021. Once the case proceeded, Ilyas plead not guilty after which a total

of four prosecution witnesses (PWs) were examined. Once all the evidence and final arguments were examined, the court declared that the complainant has initiated fabricated, vexatious litigation against the accused and is liable to issue showcase notice to the investigation officer (I.O) and to submit a compliance report to the court within 15 days. Ilyas on the other hand was acquitted on merit from the false charges on April 15, 2021.

The case took ten days to conclude. Had CWP- LAO not taken his case, he would have faced imprisonment for a term which may extend to 7



years plus a fine. After being released, Ilyas and his family were incredibly happy to be reunited and very grateful to the work done by Justice Nasir Aslam Zahid to protect the rights of prisoners in Sindh.

Financial Assistance for Khadija

hadija was around 30 years old at the time she was arrested for kidnapping. Her family background is working-class, and she is the second eldest sibling among her brothers and sisters. She was married off young but divorced not long after due to the domestic violence she faced at the hands of her husband and her

in-laws. Her second marriage bore her 5 children, whom she took care of as a housewife.

Khadija was charged with kidnapping by complainant Rabia, who had some familial enmity with Khadija as was later discovered. Once the complainant's FIR had been filed, Khadija opted for private counsel which she could only

afford for a short while. It was at this stage that she approached LAO for legal representation. Her case was then assigned to Mr. Habib-ur-Rehman Jiskani, an advocate of the Legal Aid Office, who filed a petition before the Honorable High Court of Sindh on her behalf. As a result of the petition, Khadija was granted bail in the



Shazia, gets timely help from CWP-LAO after being accused with a false kidnapping charge

43 year old Shazia had been incarcerated in prison for two years due to false charges of kidnapping. Before she got arrested, she was working in a garment factory as a laborer where she earned 10,000/- rupees per month. She belonged to a small village in Lahore where she lived with her husband, two daughters, and one son. Prior to his demise, her deceased husband had been working as a laborer and was dependent on daily wages which hardly covered their day-to-day expenses. Shazia's workingclass background thus made it extremely challenging to seek justice until LAO came into the picture.

Shazia was accused kidnapping a woman named Saima, who was running away from an arranged marriage with her cousin and from the threats of an Adeel Amjad. These false charges were filed after a chain of events involving Saima, her mother, and the man mentioned above. During her trial Shazia was not satisfied with the performance of her lawyer. so she reached out to CWP-LAO and met with lawyer Mr. Khalid Hussain Shah, who took her case on October 19, 2019. He was successfully able to get all charges leveled against her to be dismissed due to the fractures he highlighted in the prosecution witness statements. Shazia was finally



acquitted on June 15, 2021, and could have faced up to life imprisonment for a crime she did not commit if not for the right legal aid. She is thus grateful to her lawyer Mr. Shah, CWP-LAO, and their legal team for their support to get her out of prison.

sum of Rs. 50,000/-, which was also arranged by LAO as Khadija and her family could not afford it.

On June 10, 2021, Khadija was granted bail. She was very happy to have been reunited with her loved ones and thanked the efforts of her lawyer, Justice Nasir Aslam Zahid, and LAO for the

work they are doing for the rights of minorities and those vulnerable in society.



CWP-LAO **Pro Bono Partnerships**





he CWP-LAO has also been a leading voice in the struggle for speedy justice to marginalized prisoners of Sindh since 2004. We provide free legal aid assistance in petty offense cases and engage in legal literacy and empowerment, as well as advocacy work around reforming the prison system of Sindh.

In addition, we also provide legal services through pro bono partners for convicted prisoners who have been long waiting for their cases to be dismissed or appealed in the Supreme Court. Mr. Hasan Mandviwala, our pro-bono partner, visited Central Prison Karachi to interview and assess the legal documents and cases of prisoners whose appeals lie pending before the Supreme Court. He will be providing legal aid in such cases as well.
