This program aims to create a sustainable mechanism where trained convicts serve as paralegals to assist new under-trial prisoners (UTPs) zz15% of UTPs who attended the sessions demonstrated increased knowledge of the laws and norms that govern their rights and obligations.

Mr. Malik engaged with the trained paralegals and expressed strong interest in expanding this impactful model to other prisons, recognizing its potential to improve legal literacy and support for inmates nationwide.

e are proud to announce that two of our dedicated prison paralegals have been granted remission of 320 and 522 days, respectively, for their exceptional contributions to the prison paralegal program. This program, established by the Committee, trains convicts to serve as paralegals, offering crucial legal literacy to new under-trial prisoners.

The paralegal program follows a three-fold approach: know the law, use the law, shape the law. It empowers prisoners by equipping them with the knowledge of their legal rights, prison rules, and judicial processes, ensuring they can navigate the legal system more effectively. The two paralegals receiving remission have worked tirelessly within this framework, providing invaluable support to their peers and enhancing access to justice within the prison system.

Their hard work and dedication have not only transformed the lives of many inmates but also paved the way for a brighter future through this remarkable achievement.

n observance of Eid Milad-un-Nabi, the Committee organized a heartfelt event at the Women's Prison Hyderabad, featuring moving recitations and naats. Prisoners, staff, and our dedicated female lawyers actively participated in the celebration. The event concluded with the distribution of food boxes to all inmates and staff, bringing comfort and joy to the prison community.

In addition, our support extended to the Youthful Offender Industrial School (YOIS) Hyderabad, where food boxes were also provided to both inmates and staff. A total of



250 lunch boxes were distributed across both facilities, made possible through the generosity of private donors.

Free Legal Advisory Camps

he Committee prioritizes the provision of legal aid across prisons in Sindh, including efforts towards increasing prisoners' awareness regarding right to legal aid and ways to seek legal aid services.

Between July to Sep 2024, we successfully organized 20 free legal advisory camps for prisoners. The camps witnessed the active participation of 538 under-trial prisoners, including adult men, women, and juvenile prisoners who benefited from free legal advice.







Justice SUCCESS STORIES

Asif*

sif, a determined 28-year-old from Sanghar, was the cornerstone of his family's survival. His life took a harrowing turn when he was falsely accused of drug possession, a charge that seemed to shatter his already fragile world. In the midst of his struggle with poverty and uncertainty, a beacon of hope emerged in the form of Mr. Hussain Bux Chang, advocate of the Committee.

On June 25, 2024, Mr. Hussain Bux took on Asif's case with unwavering commitment, filing the vakalatnama to represent him. The legal process unfolded quickly, revealing glaring flaws in the prosecution's case against Asif. Key details were missing: the complainant and witnesses were unclear about the arrest and recovery memos, failed to describe the alleged drugs, and provided no information about the sealing and

sampling of the evidence. Crucially, there was no record of who sent the evidence for chemical examination, further undermining the prosecution's claims.

After a thorough review of the evidence and inconsistencies, the court declared Asif innocent on July 4, 2024. Remarkably, this verdict was delivered through a video call, showcasing how modern technology can enhance the legal process.

In just 10 days, justice was swiftly served, not only clearing Asif's name but also highlighting the numerous flaws in the prosecution's case. This case highlights the vital role of legal aid for those marginalized and vulnerable, proving that dedicated advocacy can turn the tide in the fight against injustice and offer a ray of hope in the darkest times.

Daniyal*

aniyal, a 26-year-old laborer from Karachi, earned about Rs. 12,000 a month to support himself and his family. Tragically, he was wrongfully convicted for an encounter with police involving an unlicensed weapon and sentenced to ten years in Central Prison, Karachi.

Desperate for help, Daniyal reached out to the Committee. His case was taken on by Mr. Habib-ur-Rehman Jiskani and an appeal was filed on December 8, 2023. During the appeal, many critical issues were revealed.

The police accused Daniyal and others of firing at them, claiming one officer was injured. However, no damage was reported to the police vehicle, and there were no local witnesses to support the story narrated by the police. Additionally, there was a significant 12-day delay before Daniyal was identified in a lineup, and the injured officer could not recognize him as the shooter. It was also found that Daniyal's name was not mentioned in

the first information report, and no physical description was provided. Furthermore, evidence showed he had been arrested from some different location days after the alleged incident.

These inconsistencies raised doubts about the police case and their intentions. On August 22, 2024, the High Court ruled in Daniyal's favor, clearing him of all charges.

After the Committee's intervention, Daniyal's case was resolved in just over eight months, saving him from nearly 8.5 more years in prison for a crime he did not commit.

Mustafa*

ustafa, a 24-year-old from Gulshan-e-Maymar originally from Badin, was the sole breadwinner for his family, earning Rs. 25,000 a month as a laborer. He found himself imprisoned in Central Prison, Karachi, facing serious charges for possessing an illegal weapon, charges he insisted were completely baseless.

Mustafa sought help during the Committee's regular prison visit. The team took his case, and his advocate, Ms. Bad-e-Saba, filed the Vakalatnama on May 6, 2024.

As the case progressed, serious flaws in the prosecution's arguments became evident. There was no evidence proving the recovery of any weapon from him, Mustafa was arrested from a different location, all witnesses were police officers

and no independent eyewitnesses were called. The prosecution struggled to establish their case beyond a reasonable doubt.

On September 6, 2024, after just four months of proceedings, the court recognized Mustafa's innocence and cleared him of all charges. With the Committee's support, he was freed from the heavy burden of false accusations and could finally return and unite with his family.

Khalique*

halique, a 55-year-old resident of Karachi, found himself in a dire situation, imprisoned in District Prison Malir for allegedly carrying gutka and mawa, a charge he claimed was false. As the sole breadwinner for his family, Khalique struggled to make ends meet as a laborer.

Recognizing his plight, the Committee assigned his case to Mr. Fayyaz Ahmed, who filed the vakalatnama on his behalf on February 26, 2024. As the case progressed, it became clear that the prosecution was weak. The complainant failed to appear in court for months, despite multiple requests, raising doubts about the validity of the charges.

Mr. Fayyaz argued passionately for Khalique's acquittal, highlighting key issues, there were no eyewitnesses, no

evidence proving Khalique was in possession of any illegal items, and discrepancies in the details of his arrest. He emphasized that continuing the case would waste the court's precious time, given the baseless nature of the accusations.

On September 10, 2024, the court agreed with Mr. Fayyaz's arguments and declared Khalique innocent, freeing him from all charges. In just 6 months and 16 days, Khalique went from being wrongfully imprisoned to returning home, relieved and grateful to finally clear his name.

Zaman*

aman, a 12-year-old boy from Karachi originally from Larkana, found himself trapped in a tough situation. He was held in a Remand Home, accused of carrying an unlicensed weapon, a claim he denied, insisting he had done nothing wrong.

Worried for help, Zaman reached out for legal assistance, and the Committee took on his case. His advocate, Mr. Waqar Mallah, filed Vakalatnama on April 18, 2024, and the case moved forward.

During the court proceedings, several inconsistencies were revealed. The complainant admitted that the incident happened in a crowded area, yet no eyewitnesses were presented. There was also no description of the supposed weapon in the arrest documents, and the details of recovered currency notes were missing. Furthermore, the prosecution

sent the weapon for expert analysis but took 27 days to do so, without justifying the delay.

Ultimately, the prosecution failed to provide enough evidence against Zaman. On August 1, 2024, the court declared him innocent, freeing him from the weight of false charges. In just 3 months and 15 days, Zaman went from being wrongfully accused to returning home, relieved and grateful.

Ali*

36-year-old laborer from Nawabshah, faced a challenging period in his life while being held in District Prison, Nawabshah. With two dependents relying on him and a modest income of Rs. 9,000 a month, Ali's life was already marked by hardship. He claimed that he was falsely accused of carrying a weapon-a charge he strongly denied, stating that it was a baseless case against him.

According to the prosecution, Ali was apprehended by the police at by Pass Road near the salt factory in Nawabshah, along with an unidentified person armed with pistols. The police alleged that both were part of a gang known for committing dacoities, which led to the criminal case against him.





Fortunately, Ali's case was taken up by Mr. Majid Ali, an advocate of the Committee, who filed a vakalatnama on his behalf on March 22, 2024. The court proceedings, which concluded after careful review of the case documents, revealed significant discrepancies. For instance, the place of the alleged incident was not blocked by any obstruction, and both the complainant and witnesses were uncertain about whether they had pursued Ali. Additionally, there were inconsistencies in the timing of the incident, and the investigation officer failed to prepare a crucial sketch of the scene.

These inconsistencies and contradictions cast serious doubt on the credibility of the case. As a result, the court found the case filled with ambiguities and contradictions, leading to Ali's acquittal. On July 3, 2024, he was released from the charges that had unjustly burdened him.

In just 3 months and 12 days, justice was served, and Ali was finally free from the shadow of criminal charges.
